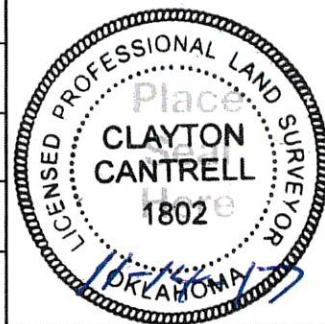


Our office has field verified that the grading modifications at 916 South Wicklow Street have been constructed in general conformance with the January 18, 2017 grading plan that was approved via email by Mike Beaty when he was on staff, and subsequent modifications due to field conditions. It is our professional opinion that the storage volume in the floodplain in the as-built condition is equivalent or greater to the pre-existing conditions.

An Elevation Certificate prepared by Crossroads Survey Company, LLC on November 14, 2017 was submitted to the City on November 15th, and shows that the house as constructed has a finished floor elevation greater than 1-foot above the mapped floodplain.
